

## SOFTWARE LICENSE AGREEMENT FOR TRIAL VERSION

### LICENSE GRANT:

OptimiData grants you a limited, nonexclusive license to use the accompanying software program(s) (the "Software") subject to the terms and restrictions set forth in this License Agreement. You are not permitted to use the Software in any manner not expressly authorized by this License. You acknowledge and agree that ownership of the Software and all subsequent copies thereof regardless of the form or media are held by OptimiData or its suppliers.

### DEFINITIONS:

#### Software:

Accompanying software program(s) delivered with download packages, including OptimiData-JPEG2000-SDK and all other deliveries as mentioned in the list of deliveries stated in the user manual.

#### Application:

Code generated using OptimiData software, or any part thereof. No part of an application is "Software".

#### Licensee:

The person or organization or company licensed under this agreement.

### LICENSE:

The Licensee shall have the right within a maximum period of one month starting from date of first use to create applications by using the software and/or use the software for evaluation purposes. Any kind of distribution of software and applications is prohibited.

### USE OF NAME AND TRADEMARKS:

Licensee shall not use the name, trade names or trademarks of OptimiData or any of its Affiliates in any advertising, promotional literature or any other material, whether in written, electronic, or other form, distributed to any Third Party, except in the form provided by OptimiData, and then solely for purposes of identifying OptimiData software.

### NO ASSIGNMENT; NO REVERSE ENGINEERING:

You may transfer the Software to another party if such party accepts the terms and conditions of this License Agreement. Upon such termination you agree to destroy the Software and documentation, together with all copies.
